

Dan Brember became Deputy Director of GOV.UK Content for the Government Digital Service in May 2022 having been Head of Policy and Strategy at GDS from January 2021. Alongside his work at GDS, Dan is also an Ambassador for the Digital Poverty Alliance whose mission is to end digital

poverty by 2030. Before joining GDS, Dan held various communications and strategy advisory positions to senior leaders across the Civil Service and politics.



Robbie Burrows joined the Northern Ireland Civil Service as a Student Programmer in July 1996. Since then, he has served in the Department of Agriculture and Rural Development, Department of Employment and Learning, the Police Service of Northern Ireland, the Northern Ireland Office and the

Department of Justice, all in ICT roles. He also spent 2 years in the Northern Ireland Office working in their Political Directorate. In August 2012, Robbie took on the role of Head of **Northern Ireland Prison Service** ICT. In this role he has responsibility for all the business-critical Northern Ireland Prison Service line of business ICT systems.



Michelle Connor is CEO of Kinva, a digital platform transforming the delivery of multi-disciplinary therapy. She is a recent winner of Innovate UK's prestigious 'Women in Innovation' Award, and a member of the Royal Academy of Engineering's Talent Engine. Kinva was named by Tech Nation as

a 'Rising Star' tech company in 2022. Michelle is a former Government Advisor on Health and Economy, and Director of Operations for an international software company. In her spare time, she is therapist to her young daughter who is disabled, and is UK and Ireland Ambassador for the charity iDefine, which supports families of children with debilitating rare diseases and funds research into ground-breaking treatments.



John Glennane, CEO and founder of Capventis, has been pursuing the goal of aligning technology, and systems to serve the real-world needs of people and business for over 35 years. In 1999 he established Capventis, a leading consultancy which helps organisations to deliver business value to

working with elected members and senior officers to create a new Digital Strategy that will focus on using the council's digital capability and the information it holds to improve service quality and customer engagement.



Damian Harvey graduated from St Mary's University College and started as a primary school teacher in North Belfast. When he progressed to being the ICT co-ordinator at his school, he led his school to a C2k ICT Excellence Award and then collected the top prize at the Times Educational Supplement

EdTech School of the Year in 2003. Damian is now Interim Head of C2k and more recently he has led C2k in the delivery of Education Technology services to almost 1,100 schools. He is currently involved in leading a Portable Teacher Device strategy which has delivered over twenty thousand MS Surface Pro 7 Plus devices and Professional Development to all Nursery, Primary, Special and Post Primary teachers in Northern Ireland.



Geoff Huggins is Director for Digital at the **Scottish Government**. Previously he was Director of the NHS Education Scotland Digital Service working to create the NHS National Digital Platform. From 2013 to 2018 he was Director for Health and Social Care Integration and from 2017 to 2018 also

Director for Digital Health and Social Care. Prior to that he was Head of Mental Health for nine years. From 1991 to 1998 he worked for the Northern Ireland Office working on security and political development. He holds degrees in law and criminology from Queen's University, Belfast. He is a non-executive director of Cornerstone, Penumbra and the International Initiative for Mental Health Leadership.



Bill McCluggage is Managing Director of Laganview Associates Ltd. He became the first CIO for the Irish Government in 2013 and was CIO for the Northern Ireland Civil Service (2005 – 2009). He joined the Cabinet Office in 2009 as deputy UK Government CIO. While in the Cabinet Office he was the

Executive Director responsible for the UK Government's ICT Strategy and was instrumental in the development of the Government G[1]Cloud, and was SRO for the Identity Assurance Programme, now GOV.UK Verify.

Suzanne McLaughlin is the Chief Survey Officer of Ordnance Survey Northern Ireland which is a Directorate of Land & Property Services. She has a PhD from Ulster University and is a Chartered Geographer and past Chair of the Ireland & Northern Ireland branch of the Chartered Institute of Civil Engineering

Surveyors. She has years of experience in the GI sector. She was instrumental in creating the Northern Ireland GI Strategy 2009- 2019 to educate and encourage greater use of GI in government. She also wrote & implemented the first Open Data Strategy for NI.



Dan West is the Chief Digital Information Officer (CDIO) for Health and Care in Northern Ireland at the **Department of Health**. His role is about seizing the opportunity to use data and technology to improve health and care experiences and outcomes in the region, and to create an

economically sustainable service for future generations. The CDIO post is part of the Department of Health board, bringing responsibility and leadership for Digital into the centre and concentrating six key levers into one place – strategy, policy, funding, governance, decision making and system-wide design. Dan will work to build on existing achievements with the excellent teams across the health and care eco-system, including the Health and Social Care Board, Public Health Authority, Business Services Organisation and the Trusts as well as the GP community and academic and private sector partners. Dan comes to the Department of Health with over 20 years' experience of technology led transformation in central government and healthcare organisations around the world.



Emma Weston leads one of the most innovative digital inclusion organisations in the UK. **Digital Unite** works with public, third sector and private organisations developing and delivering creative, impactful learning and training, so organisations can embed digital inclusion and essential digital skills in

their workplaces and cascade them to customers, colleagues and service users. By Foot

Titanic Belfast is only 2.4km (1.5 miles) away from Belfast City Centre; a pleasant 25-30 minute walk.

By Car

Vehicles approaching Belfast on the M1 or M2 should follow the signs to Belfast City Airport M3, taking the first exit for Titanic Quarter. There are 520 secure, underground paid parking spaces available. Parking charges are £2 for the first hour and £1 per hour thereafter.

From here there is pedestrian access via a footbridge, please then follow signage to Titanic Belfast. Walking time is approx. 15 mins from station.
